These services included mental health, medical and legal, housing and employment, assistance applying for benefits and obtaining identification cards, and help meeting immediate needs such as clean clothing and transportation to important appointments.

4b (Code:) (Expenses \$ 722,960. including grants of \$) (Revenue \$) Miriam's Kitchen is a reliable source for hot meals and a warm supportive environment for men and women who are homeless. 1,916 volunteers helped staff this program in fiscal year 2014, The meals program served 86,709 meals to our homeless guests.

4c (Code:) (Expenses \$ 625,082. including grants of \$) (Revenue \$ 429,210.) Miriam's Kitchen provides supportive services to 95 formerly chronically homeless individuals in the DC Department of Human Services Permanent Supportive Housing Program (DHS PSHP), who live in units located throughout the city. Once clients are matched with housing, Miriam's Kitchen serves as a coordinator and advocate between clients, their landlords and service providers, an essential strategy for housing retention.
